Dear Atchison Village Members,

As you know, we are dedicated to doing everything we can to best serve our membership, including preserving the status of our unique community. Atchison Village is the last Mutual Housing Corporation on the West Coast. The decision of the Contra Costa County Tax Assessor changed their view from a Mutual Housing Corporation to that of a Stock Cooperative, which carries different financial implications to the membership when buying and selling units.

While preserving the mutual housing corporation status is very important, we must take into account all implications of preserving our unique community. Since the County has taken action against Atchison, the next step will be to essentially sue Contra Costa County to preserve our Mutual Housing Corporation status with the assessor's office.

Do note that although in the eyes of the County Assessor's Office, we are, and have been for years, been assessed similar to a Stock Cooperative. Classification does not change how the corporation operates internally or how other outside entities may view Atchison.

The Board is balancing many factors to determine whether to move forward with a suit or not. The two major factors include the cost to pursue this action and likelihood of success. To get where we are so far incurred significant costs to Atchison. Pursuing this action further will incur significantly more costs.

The second factor we must overcome is the likelihood of success. No case is ever a "slam dunk," this case included. We could incur additional fees, all to end up in the same position we were in when we started. Overall, these are just two of the factors to decide whether to pursue the tax appeal further. In the meantime, we are also working with the County concerning transfers of units during the appeal period.

As our appeal navigated through the Tax Assessor's office, previous counsel recommended that we pause reporting transfers. Under the current status quo, we will have to report those transfers. By working with the County, we hope this matter will be

resolved smoothly so that if the board either elects not to pursue further appeal or if the appeal is not successful, we will be in the best position possible. More details concerning this are to come.

Thank you in advance for your patience in this matter. After waiting for more than a year for the County's decision, we are finally able to make these large strides for Atchison.

Save Rainwater with Easy Catchment

All the rain this winter got us thinking about how we could store some of it for our garden once the dry months arrive. A search on Facebook marketplace led to a family in San Pablo that sells food-grade 55-gallon widemouth plastic barrels for around \$30.

We knew another storm was coming so we drove over and picked one up. We placed our barrel under our front porch gutter with the lid off and within a few days it was full. We now have 55 gallons of water to use when we need it—we simply unscrew the top and scoop it out with a watering can. The barrel mouth is wide enough that as the water lowers it will still be easy to reach in.


