#### Wild Edibles in Atchison Village

I moved here in March. Walking in our park, I noticed several edibles that can be used in salads: two different types of wild plantain plants, one with narrow leaves, the other wide.

The wide one is Broadleaf Plantain, which has several veins that run the length of the leaf. The narrow-

leafed plantain is Long Leaf or Narrow Leaf Plantain; it also has veins that run through the leaf. I shred them to put in salads. They have anti-bacterial benefits. If you get a bee-sting, chew some to make a poultice and put it on the sting. It should start working immediately.

Those tiny daisies you see in the grass? Those are edible, as are the white clover flowers and 3-petaled leaves. I love the dandelion greens I find too. I just



learned that the yellow dandelion flowers are also edible: they're good, almost sweet!

Oh, and once I found a patch of meadow mushrooms after a rain. Meadow mushrooms are plentiful and easy to identify, although I don't recommend it unless you really know what you're doing.

**MOTION RE07092025.04** that the Board of Directors for Atchison Village Mutual Homes Corporation ("Board of Directors") adopt and implement the following record keeping policy for motions passed by the Board of Directors:

All motions passed by the Board of Directors shall be recorded in a standardized format that is readily and easily readable and accessible, and which shall include, at minimum, the following information:

- (a) Title of the motion:
- (b) Text of the motion;
- (c) The name(s) of the Director(s) who made the motion;
- (d) The name(s) of the Director(s) who seconded the motion;
- (e) The names(s) of each Director who voted "yay," "nay," or "abstain";
- (f) The effective date of the motion;
- (g) The amount of funding, if any allocated by the motion;
- (h) The expiration date, if any, of the motion;
- (i) Excepted under this motion are procedural, non-substantive motions.

The record of these motions shall be maintained in a binder or folder in the Corporation's office, which shall be labeled "Corporation Motions," shall be available for inspection by any member during normal business hours, and shall be maintained in perpetuity.

The Secretary-Treasurer or his/her designee(s) shall implement this policy forthwith, and shall ensure compliance with its requirements. This policy shall be implemented and effective as of July 15, 2025. This

policy shall continue in perpetuity, until such time as it is altered or repealed by the Board of Directors. Moved by Michael Lopez, seconded by Margarito. Ayes: unanimous

**MOTION RE07092025.05** Motion to Implement Record Keeping for Corporation Purchases and Expenditures. I move that the Board of Directors of Atchison Village Mutual Homes Corporation ("Corporation") adopt and implement the following record keeping policy for Corporation purchases and expenditures:

All Corporation purchases and expenditures shall be documented using the Standard Purchase and Expense Form, which shall be updated and amended as needed. For every Corporation purchase and expenditure appropriate documentation, such as receipts, shall be attached to the Standard Purchase and Expense Form. All Corporation purchases and expenditures shall be approved by a person authorized to sign on behalf of the Corporation (President, Vice-President, or Secretary-Treasurer).

Every completed Standard Purchase and Expense Form shall be placed in a binder or folder, which shall be labeled "Corporation Purchases and Expenses," stored in the Corporation's office, and shall be available for inspection by any member during normal business hours. This binder or folder shall contain all records for purchases and expenditures incurred for the current calendar year, after which time they shall be stored and retained pursuant to the Corporation's record retention policy. If the Corporation makes a purchase or expends funds for a particular unit(s), a copy of the Standard Purchase and Expense Form shall also be placed in that unit(s) file. The Secretary-Treasurer or his/her designee(s) shall implement this Corporation policy forthwith, and shall ensure compliance with its requirements. This policy shall be implemented and effective as of July 15, 2025. This policy shall continue in perpetuity, until such time as it is altered or repealed by the Corporation. **MOTION RE07092025.06** Motion to Provide for Simultaneous Translation of Public Meetings of the of Directors for Atchison Village Mutual Home Corporation.

1 move that the Board of Directors for Atchison Village Mutual Homes Corporation ("Board of Directors") adopt and implement a policy to provide for simultaneous translation of all public meetings of the Board of Directors into both English and Spanish. Such simultaneous translation shall include the ability to see, hear, and/or read communications that occur during the official proceedings of these public meetings in both English and Spanish. The Board of Directors authorizes an expenditure not to exceed \$1,200.00 per calendar year to implement this policy. The President or his/her designee(s) shall implement this policy of the Board of Directors forthwith, and shall ensure that it is complied with at each public meeting of the Board of Directors. This policy shall continue in perpetuity, until such time as it is altered or repealed by the Board of Directors. Submitted by: Michael Lopez. Moved by Michael Lopez, seconded by Milly. MOTION RE07092025.07 Motion to Ensure Transparency for Actions Taken by the Board of Directors of Atchison Village Mutual Homes Corporation. I move that the Board of Directors for Atchison Village Mutual Homes Corporation adopt and implement the following policy: All votes by the Board of Directors, that substantially affect the members of Atchison Village Mutual Homes Corporation shall only be conducted in a public meeting, that is advertised in advance to all members, and that is open to all members to attend and participate in, with all underlying documents available for review, allowing all members the ability to make comments and ask questions. For purposes of this motion, "substantially affect" means a vote or decision by the Board of Directors on any issue that may have a significant or considerable impact on the rights or obligations of members, including but not limited to, alteration to an important policy or procedure common to all members, including, but not limited to, altering the availability of members to transact business, such as the ability to pay dues, in the Corporation Office, third-party contracts for professional services that exceed \$10,000.00 in any single calendar year, and third-party contracts with any individual and/or business entity to perform management, or other services. "Substantially affect" also means any vote that will affect ten or more units, and/or ten or more members, in a significant or important way. Nothing in this motion shall restrict the ability of the Board of Directors to meet in a closed session for consideration of litigation, delinquent assessments, or personnel matters. A member's right to an open meeting for any issue concerning member discipline involving that member is deemed a fundamental right and shall not be infringed. This policy shall continue in perpetuity, until such time as it is altered or repealed by the Board of Directors. Moved by Casey Bastiaans, seconded by Ron. Ayes: unanimous
